New Market Tax Credits are a resource to finance business investments in low-income communities by providing investors with state tax credits in exchange for delivering below-market-rate investment options. Investors receive a 39% tax credit spread over seven years if they make an investment in a qualified low-income community business. Explore how the program is sparking revitalization in Arizona in both metro and rural areas, and how you may be able to take advantage of the program to recruit companies to your community.
